# TERMS & CONDITIONS

Memorabilia Kings shall be known in these terms and conditions as "MK".

The party or parties who engage the services of MK shall be known in these terms and conditions as "the Client".

By engaging the services of MK for the purpose of providing memorabilia on consignment for fundraising events or similar, it is understood by the Client that the following terms and conditions shall apply.

## **Memorabilia Items on Consignment**

MK will supply items of memorabilia as chosen by the Client on a consignment basis for use at an agreed fundraising event/s. The supplied memorabilia shall not be used for any other purpose.

## **Reserve Price**

A reserve price determined by MK will be placed on each item provided to the Client for the purposes of auctioning the said item at the nominated fundraising event.

The Client agrees that the item cannot be sold unless the reserve price is attained.

## **Payment**

The Client agrees to pay to MK the nominated reserve price for all items sold at the immediate completion of the event, unless all reserve prices have been paid prior to the event.

The Client agrees that collection of all funds owing for items sold are the sole responsibility of the Client. The client agrees and understands it will be accountable to MK for payment for all items sold at the Client's fundraising event.

The Client agrees and understands that should it elect to allow a third party to take possession of an item of memorabilia prior to the third party paying for the item, then the Client accepts full responsibility and payment obligation to MK should the third party fail to make payment in full at the immediate completion of the event.

## **Payment Methods**

MK will accept payment from the Client by the following methods:

1. Cash;
2. Electronic funds transfer to MK bank account;
3. Credit card payment; or
4. Bank cheque

## **Damage**

The Client understands and agrees that it is totally responsible for any damage to any item of memorabilia, whether accidental or not, whilst the items are in the possession of the Client.

All items shall be checked by both MK and the Client (or nominated representatives of each) at the time of delivery and at the time of pick up to confirm that all items are in good condition and without damage.

Should damage be caused to any item, whether accidental or not, the Client understands and agrees that it will be obliged to pay for such damage at the immediate completion of the event.

## **Possession**

The Client accepts and understands that possession of the items of memorabilia will be deemed to have been given at the time that the said items are delivered by MK to the Client, or such items are collected by the Client from the premises of MK.

The Client agrees to sign an acknowledgement at the time of taking possession of the items of memorabilia as to the good condition of same and acceptance of responsibility for the maintained good condition from the time of taking possession.

The Client accepts and understands that all items of memorabilia remain the absolute property of MK until such time as payment in full has been made to MK.

### **• Additional costs**

The client agrees that some additional cost will be incurred and paid for prior to the event and supply of any memorabilia.

These include:

- Guest Speakers
- Delivery and Pickup of memorabilia
- Auctioneers
